



The U.N. Sustainable Development Goals


On 25 September 2015, the UN General Assembly adopted the 2030 Agenda for Sustainable Development. This new global framework to redirect humanity towards a sustainable path was developed following the United Nations Conference on Sustainable Development (Rio+20) in Rio de Janeiro, Brazil in June 2012, in a three-year process involving UN Member States, national surveys engaging millions of people and thousands of actors from all over the world.

At the core of the 2030 Agenda are 17 Sustainable Development Goals (SDGs). The universal, transformational and inclusive SDGs describe major development challenges for humanity. The aim of the 17 SDGs is to secure a sustainable, peaceful, prosperous and equitable life on earth for everyone now and in the future. The goals cover global challenges that are crucial for the survival of humanity. They set environmental limits and critical thresholds for the use of natural resources. These goals recognize that ending poverty must go hand-in-hand with strategies that build economic development. They address a range of social needs including education, health, social protection and job opportunities while tackling climate change and environmental protection. The SDGs address key systemic barriers to sustainable development such as inequality, unsustainable consumption patterns, weak institutional capacity and environmental degradation. The [UNESCO Competency Framework](#) provides an inventory of expected behaviors, skills and attitudes that lead to successful performance in addressing the 17 SDGs.

Ubiquity's learning system is mapped to the UNESCO SDG competence framework so that you and others can see how well equipped you are to deal with one or more of the SDGs.




The Ubiquity Learning Experience

Ubiquity University draws its academic inspiration from the School at Chartres established in Chartres, France in the Middle Ages. Around c. 1020, Bishop Fulbert pioneered a new focus for the school, and it became renowned around Europe as a chief learning center that focused on the original seven liberal arts. Now, informed by the 17 UN SDGs and their UNESCO Competency Framework, Ubiquity is reinventing the traditional seven liberal arts for a new societal context. We call it the **Chartres Framework**, and we use it to encode our learning experiences with the newly re-imagined **Seven Changemaker Competencies**.

Changemaker Competencies are the kinds of *qualities and skills* needed to assist society at *this time of transition* from an unsustainable trajectory to a pathway that is ecologically viable, life-affirming and brings out the best of our human potential. Each course has a set of learning outcomes that support our seven core competencies, so you know exactly what abilities you'll gain by the end of each course.

In fact, the Chartres Framework generally guides all our operations – from Ubiquity's mission (including the Code of Ethics and Our Values) to our courses that are carefully formulated to catalyze the skills and abilities you need to effectively engage in our rapidly changing world.




The Chartres Framework & Seven Changemaker Competencies

Meeting Global Challenges	The ability to understand global challenges and to align your daily authentic life with the needs of the planet through embodiment, mindfulness and meditation.
Teamwork and Collaboration	The ability to respect diversity and act with others in such a way that each person's passion and ability is maximized for the good of the whole.
Social Innovation & Entrepreneurship	The ability to identify, conceptualize and implement an innovation in society in such a way that all stakeholders benefit.
Emotional Intelligence	The ability to be aware of and manage your own emotions and creatively engage with the emotions of others.
Critical Thinking & Problem-Solving	The ability to critically evaluate information and identify its interrelation to other domains of knowledge to enable interdisciplinary and life-affirming solutions.
Leadership	The ability to steward yourself with balance and inspire others into meaningful action in such a way that each person activates their highest potential to work together on common challenges.
Building Global Community	The ability to build, nurture and activate intercultural relationships while driving action in service of global wellbeing.

In order to facilitate the integration of these competencies, we've divided them into three areas that align with the natural divisions found in the human organism since antiquity: **Knowledge Content** (head – the things you are going to study), **Personal Qualities** (heart – the dimensions in yourself you are going to develop), and **Action in the World** (hands – how you engage in the society around you). All of your study and program-related activity at Ubiquity will contribute to the development of these core competencies.

Finally, we use the **Four Integral Quadrants** to ensure that your personal learning stays aligned and in harmony with the world in which we live, leading to personal fulfillment and professional success. Together, the Chartres Framework (Seven Changemaker Competencies), Tripartite Learning Design, and Integral Quadrants comprise the core elements of Ubiquity's learning system.

Ubiquity's Integral Learning Design






Course Structure, Credits & Grading

Course Structure, Credits & Grading

For Ubiquity's independent degree programs hosted entirely on the Ubiquity platform we have a variety of "build-your-own" learning programs comprising the various courses described below. For learners in our Partner Programs, while this information may be less relevant for your specific program requirements, it's still a valuable overview of what is offered at Ubiquity and what additional options may be available to meet your academic needs.

To best understand our various course types and modalities described in the sections below we encourage you to review the handbook descriptions and then view our "Courses" tab on the [Ubiquity website](#).



Course Types & Credits

Trimester Courses (3-credits)	Trimester Courses consist of between 36 and 48 hours of coursework delivered in 12 (twelve) to 15 (fifteen) weeks with a Final Creative Assignment that provides a comprehensive overview of a particular subject.
Microcourses (1-credit)	Microcourses consist of 12 hours delivered in 4 (four) weeks. Microcourses can be bundled together in groups of three with a final Creative Assignment that comprises content of all three in order to be accepted for academic credit.
Nanocourses (1/4-credit)	Nanocourses consist of 3 hours delivered in 1 (one) week that provide a deep dive into a single concept. Nanocourses can be bundled together in groups of twelve with a final Creative Assignment that comprises content of all twelve in order to be accepted for academic credit. In this way, twelve nanocourses are equal to 3 credits.
In-Person Courses (4-credits)	Ubiquity offers various in-person learning journeys throughout the year for all students. These courses require in-person attendance and then a written report at the BA, MA or PhD/DMin level depending on your academic program in order to receive academic credit for them.
Live Webinars (1-credit)	Live Webinar courses are normally four to six weeks with live webinars once per week.
Partner Courses	As mentioned above, Ubiquity also awards academic credit for courses taken with our Learning Partners. Our Learning Partner students are subject to a revised set of academic requirements that can be found in the "Program Requirements" section of the "Graduate Degrees with Partner Institutions" segment.

Course Modalities

Live Virtual Classroom:

- Study that takes place within Ubiquity University, in which Ubiquity academic coursework is accomplished through attendance in Live Webinars, with faculty and student interaction being a part of the Live Webinar content.
- To receive academic credit, you must not miss more than 3 live sessions, you must complete the quizzes and submit any other required assignments (if any), and submit your Reflection Journal and your Final Creative Assignment for grading at the degree level you are enrolled in.

Internal Online Independent Study:

- Study that takes place within Ubiquity University, in which Ubiquity academic online coursework is engaged independently on one's own and does not include faculty interaction.
- To receive academic credit, you must complete the quizzes and submit your Reflection Journals and Final Creative Assignment for grading at the degree level you are enrolled in.

External Independent Study:

- Study that takes place outside of Ubiquity University in other academic venues.
- If you intend to transfer these courses for academic credit, and the course is not offered by one of our approved providers, you MUST complete and submit an External Independent Study form for approval prior to embarking on coursework outside Ubiquity University.
- You must provide proof of attendance, submit a Final Creative Assignment and pay credit fees at your degree level.

Grading System

At Ubiquity University, grades are assigned based on academic performance, understanding of the subject matter, and demonstration of critical thinking, research, and analysis. Below is the grading scale used for evaluating coursework and final assessments:

A (Excellent: 90–100%)	Outstanding work demonstrating deep understanding, originality, critical thinking, and strong analytical skills. Writing is clear, well-organized, and thoroughly supported by evidence.
A- (Very Good: 85–89%)	Strong academic performance with only minor weaknesses. Demonstrates a high level of understanding and critical thinking but may lack the depth of an A-grade submission.
B+ (Good: 80–84%)	Solid understanding of the subject matter with good analysis and research. Some minor gaps in reasoning or structure but overall well-executed.
B (Satisfactory: 75–79%)	Competent work that meets all the requirements, though it may not demonstrate a high level of originality or insight. Writing and argumentation are clear but may need further depth.
B- (Adequate: 70–74%)	Meets the basic requirements but lacks depth, analysis, or coherence in some areas. Demonstrates an understanding of key concepts but needs improvement in critical thinking or presentation.
C+ (Acceptable: 65–69%)	Shows a general grasp of the subject but with noticeable weaknesses in clarity, argument structure, or evidence. Limited engagement with deeper aspects of the topic.
C (Satisfactory but Needs Improvement: 60–64%)	Work is acceptable but has significant issues in understanding, organization, or execution. Minimal critical analysis, with some errors or underdeveloped arguments.
C- (Borderline Pass: 55–59%)	Demonstrates minimal competence but contains significant gaps in comprehension, argumentation, and clarity. Requires substantial improvement.
D+ (Below Average: 50–54%)	Work is weak and lacks coherence, depth, or strong argumentation. Barely meets academic standards. Shows limited effort or engagement with the subject matter.
D (Poor: 45–49%)	Inadequate performance with serious weaknesses in understanding, research, and writing. Lacks a clear argument or structure, with major gaps in content.
D- (Very Poor: 40–44%)	Work is barely passing with significant flaws in content, analysis, and organization. Does not meet the basic expectations for graduate-level work.
E (Failing: Below 40%)	<ul style="list-style-type: none">Does not meet the minimum requirements. Work lacks coherence, analysis, and effort. Submissions with excessive errors, lack of research, or failure to address the topic will receive this grade.A grade of E is considered a failing grade, requiring the student to retake the course or complete additional work as determined by the instructor or program guidelines.

Live Virtual Classroom

- Attendance and participation in live virtual sessions with faculty
- Completion of quizzes
- Completion of a Reflection Journal that captures reflection task questions and answers, and that is submitted at the end of the course for grading.
- Participation in group discussion questions both in our online forum and during your live faculty sessions
- Completion of a Final Creative Assignment that is submitted at the end of the course for grading.

Internal Online Independent Study

- Completion of all video and reading assignment lessons
- Completion of quizzes
- Completion of a Reflection Journal that captures reflection task questions and answers that is submitted at the end of the course for grading
- Completion of a Final Creative Assignment that is submitted at the end of the course for grading




Alumni Group:

As a result of Ubiquity's strict academic and professional standards guided by Ubiquity President Dr. Jim Garrison (Harvard University, Cambridge University) and Dean of Graduate Studies Dr. Gyorgyi Szabo (Universite Sorbonne) we are proud to maintain an esteemed reputation for our students and alumni among employers and other academic institutions worldwide.

Academic Misconduct

At Ubiquity University we take academic misconduct seriously as an expression of our commitment to protecting the integrity of our community members' learning journeys. A student shall be subject to dismissal from the University for any of the following infractions:

1. Violation of Ubiquity's Code of Ethics or other standards associated with the institutions in which the student is engaged;
2. Plagiarism, including, but not limited to, recent generative AI software services;
3. Failure to achieve satisfactory marks in two courses whose final due dates or formally-granted extensions for work to be submitted have expired; or
4. Other general conduct deemed incompatible with the policies of Ubiquity University as an outcome of an Academic Standards Committee Review.



Academic Standards Committee Review

The case of each student subject to dismissal, as set forth above, shall be reviewed by the academic standards committee of the University, which is made up of the President, the Dean, and their appointees. The committee may provide the student with a path to remedy the situation or may schedule a hearing at which the student's dismissal from the University will be considered. It is the responsibility of each student to ensure the University is informed of a current email address for receipt of official notices.

Dismissal Hearing Process

A hearing will be conducted in those instances when the academic standards committee recommends dismissal. This hearing shall be conducted before a body composed of the academic standards committee, all of whom shall have full voting rights. The hearing will be conducted via online video conferencing solutions.

The student has the right to be accompanied to the hearing by an advocate of their choice. Each student scheduled for a hearing shall have the right to be notified of occurrence and cause of the hearing, to personally appear before the committee, to make a statement, and to present facts relevant to the determination to be made by the committee. In any case involving unsatisfactory academic performance, the committee shall consider potential for academic success and the extent to which extenuating circumstances affected the student's performance.

At the conclusion of the hearing, or within five days thereafter, the committee shall notify the student of its decision, which will be determined by majority vote.

Reinstatement

Unless the committee has explicitly made the dismissal permanent, a student who has been dismissed for reasons set forth in items 1-4 above may petition for reinstatement to the same degree program, or apply to another degree program at the University, after a time period of one year from the date of the Review Committee's decision. The petition or re-application shall state in full the circumstances of the dismissal and the actions taken by the student to correct the condition(s) that led to dismissal from the University.

Reporting Ethics Code Violations

Frequently Asked Questions

Q: I can't afford the full tuition upfront. What other options do I have?

A: All students pay as they go, meaning you can pay for each course or program requirement as your budget allows. For circumstances involving financial distress, payment plans will be considered on a case-by-base basis. Ubiquity is not eligible for FAFSA and does not offer private scholarships, grants, or loans. The Admissions Office can provide further information on 3rd party funding services.

Q: Can I pay in total upfront if I want to?

A: Ubiquity allows total payment upfront on a case-by-case basis in coordination with the Director of Admissions and Registrar's Office.

Q: What forms of payment do you accept?

A: All courses must be paid for through Ubiquity's online Community Platform which has several forms of payment available, including most major Credit Cards (Visa, Mastercard, American Express, Discover), Direct Bank Transfer, or Paypal.

Q: Are there other expenses associated with my studies besides the tuition?

A: No. Ubiquity commits to remaining globally affordable and does not have any hidden fees. What you see in your tuition payment includes the total amount you need to pay. Our application process is free. Resources are either freely available on our Community Platform or elsewhere on the web. In the rare occurrence where we cannot make textbook resources available digitally for free, we seek purchasing options with nominal fees compared to what a learner would pay for a traditional textbook.

Q: How much class work do I have to do?

A: About 3 hours of weekly online coursework per module, per course.

Q: How much homework do I have to do?

A: About 4–6 hours of weekly offline coursework per module, per course.

Q: How will I receive my course grades?

A: Course marks are made available within your personal profile on our Community Platform under each course listed in your My Courses section.

Q: How do I submit my homework assignments?

A: Assignments may be submitted through our Community Platform within each course module or directly to the faculty you may be working with. Consult with your course instructor to determine the best way to submit your assignments.

Q: How flexible is the homework deadline schedule?

A: You can work on homework as your schedule allows in consultation with your course instructor.

Frequently Asked Questions

Q: How do I communicate with Ubiquity staff?

A: Each course you take has assigned staff support you will learn about during registration. They will be your main point of contact for your online content. Additionally, you can always communicate easily and directly with our help desk using the [Contact Us](#) form on the main Ubiquity site. And, our Dean of Students is always available for additional support.

Q: What if I want to take a break between trimesters?

A: No problem! That's part of the beauty of online, pay-as-you-go education. Simply touch base with our Dean of Students to coordinate your gap term. You can come back to Ubiquity at any time.

Q: What if I get stuck with technical issues and I need help?

A: You can always ask our [Help Desk](#). If it is a content or technical question, they will make sure you are directed to the right person.

Q: How tech savvy do I need to be to attend the classes?

A: The Community Platform has been designed to be very user-friendly. If you are an average user of computers and the internet then you will find it very easy. Master of Arts Degree at Ubiquity (MA)

Master of Arts (MA) in Wisdom Studies

Introduction

The MA in Wisdom Studies program is the flagship Master's program at Ubiquity University. Bringing together our integral combination of scholarly research, self-reflection, and application to a specialized context of your choosing, this program is designed to elevate your expertise and advance your contribution to a targeted area of study.

The core work of your program revolves around a robust writing process that results in a thesis you have the option to publish through Ubiquity's publishing service. While you receive supportive guidance for this process through Ubiquity's dissertation writing course and group meetups, the major opportunity of this program is to take advantage of the freedom and self-guidance to explore transformational topics for which Ubiquity is designed.

Upon completion, you will be awarded the title "Master of Arts". This is an honor that society bestows, indicating respect for and acknowledgement of an expertise that the larger community can count on for its integrity and professionalism. Embarking on this master's degree should not be taken lightly. It is a challenging process, one that will require extensive time, effort, and commitment.

Program Goals

This MA differs from other Master's programs due to its high-level research and writing focus. The Master's Thesis must demonstrate excellence at every level. This includes an awareness of the history of the literature in your particular area; demonstrating careful analysis and understanding of the field in question; and, most importantly, offering an original contribution to the field. Your Thesis must be scholarly and utilize extensive bibliographical data and footnotes. It should, in other words, be an impeccable work of research.

For our MA in Wisdom Studies program, each prospective student must apply directly to our Dean of Graduate Studies who will contact you to discuss your aspirations and potential pathways. All masters students must supply transcripts of previous education and write an essay indicating the area of research they wish to explore.

This Master's program is open to a spectrum of disciplines and interests. It aims to address a range of problems in almost every area of human and ecological concern. The program is dedicated to supporting your desire to shape and co-create a new global civilization, contributing to the idea that the human species can learn to act as a responsible and caring part of our larger planetary ecosystem.

Courses

Master's students must complete a selection of core courses offered by Ubiquity University, additional credits from Ubiquity or elsewhere as specifically relevant to your chosen field of study and research, as well as complete a formal dissertation.

Core Courses (8 Credits):

A set of 2 (two) required Trimester Courses:

- Ubiquity Chartres Academy, meeting annually in Chartres, France (4 credits in-person or online)
- The Creative Journey to Dissertation: Finding your Voice, Making your Mark (Gyorgyi Szabo, PhD) (4 credits online)

Elective Courses (12 Credits):

An additional four (4) Trimester Courses (or equivalent micro, nano, or in-person courses), you take based on your interests.

You can choose your remaining courses from the selection of online trimester, micro and nano courses, and in-person learning journeys or additional coursework from another source approved by the Dean of Graduate Studies.

Thesis (10 Credits):

Complete your academic dissertation paper, review, and approval processes.

Doctoral Degrees at Ubiquity (PhD, DMin)

Introduction

Our doctoral program is the *Jewel in the Crown* of Ubiquity.

Upon completion, you will be awarded the title “Doctor of Philosophy” or “Doctor of Ministry.” This is the highest honor society bestows and indicates respect and acknowledgement for an expertise that the larger community can count on for integrity and professional competence. A PhD and DMin should not be taken lightly. It is a challenging process, one that will require extensive time, effort and commitment.

The dissertation must demonstrate excellence at every level. The dissertation must show awareness of the history of the literature in your particular area; demonstrate careful analysis and understanding of the field in question; and, most importantly, offer an original contribution to the field. The dissertation must be scholarly and utilize extensive bibliographical data and footnotes. It must be an impeccable work of research.

Very importantly, our dissertation requirements involve what we call the “Object/Subject Synthesis.” This means that in your dissertation we are interested in your command of the objective knowledge you are studying. We are equally interested in your subjective response to what you are learning. How is your dissertation affecting your personal growth and development? Our Object/Subject Synthesis seeks to harmonize left brain and right brain functions so that your dissertation is a work of the intellect and also a work of art. Ubiquity dissertations welcome prose and poetry, hard facts and analysis and spiritual growth and intuitive expression.

In this way, the PhD dissertation is a qualitative research document. It demonstrates the student’s ability to plan, conduct, write, and defend an original research study. There are a range of areas of concentration within the general domain of “Wisdom Studies” in which students can earn a PhD degree. Both the choice of the Major Advisor and the choice of Intensives during the course of study should support the chosen area of concentration. Successful dissertations can range from more traditional qualitative research to creative artistic projects and/or social activism, so long as the inquiry utilizes a research methodology. Examples of more traditional qualitative methods include phenomenology; grounded theory; ethnography; historical; narrative, and case study. Some of the more innovative research methodologies include arts-based research, organic inquiry, and indigenous methods. Your choice should reflect who you are and what you deem to be important for your academic and spiritual growth.

In the end, the choice is intensely personal. It may be a topic that one has reflected on for some time or is an area of burning interest for further exploration. Successful dissertations can range from pure research to creative artistic projects and/or social activism. For example, one can research a particular mystic, historical event, or area of spiritual concern.

Ubiquity University is pioneering a unique educational vision that puts the student at the center of our learning system – you, the student, design what you need to learn. We are here to support your pathway. At every level, you are supported by mentors and coaches who work with you to ensure that you are getting exactly the kind of education you need for what you want to do in the world.

Areas of PhD Concentration

We offer the following specific concentrations:

PhD in Wisdom Studies

This is Ubiquity's original PhD program. It involves a deep dedication to in-person and online holistic learning that emphasizes the heart as much as the head, artistic expression as much as intellectual rigor, the body as much as the soul. The Wisdom courses seek to bring balance through diversity, harmony through dialogue, and union through polarity.

DMin in Engaged Wisdom

The DMin is specific to the pastoral and therapeutic communities. It arose originally for ministers seeking a doctoral degree but who were less interested in the pure research required for a PhD, and more interested in the applied research in areas of healing, therapy, spiritual growth and counseling they were seeking to apply in their professional work.

Combined MA/PhD Wisdom Studies

Our combined Master's and PhD program in Wisdom Studies offers a comprehensive journey through a diverse array of disciplines, confronting the complex challenges and opportunities inherent in human and ecological interactions. Upon completion, graduates receive a dual credential of a Master's followed by a Doctorate in Wisdom Studies, positioning you among a distinguished group recognized for their high level of scholarly achievement.

Combined MA/DMin Engaged Wisdom

Our combined Master's and DMin program in Engaged Wisdom offers a comprehensive journey through a diverse array of disciplines, confronting the complex challenges and opportunities inherent in human and ecological interactions. Upon completion, graduates receive a dual credential of a Master's followed by a Doctorate in Engaged Wisdom, positioning you among a distinguished group recognized for their high level of scholarly achievement.

Doctor of Philosophy (PhD) in Wisdom Studies

Program Design

Our Ubiquity PhD program is composed of 60 credits consisting of 8 study macrocourses, (or their equivalent to reach 24 credits), and a doctoral dissertation worth 36 credits.

(Given the requirement to have a master's degree before pursuing a doctoral degree, we also have a combined MA/PhD in Wisdom Studies enabling you to get your MA qualification first and then continue studies toward your PhD. This program is composed of 80 credits consisting of 12 study courses (or their equivalent) to reach 44 credits, and a doctoral dissertation worth 36 credits. Please discuss with the Dean of Graduate Studies.)

Courses

Doctoral students are required to complete three core courses offered by Ubiquity University as well as write a doctoral dissertation. The remaining courses can be taken from Ubiquity or elsewhere as specific courses related to your chosen field of study.

Core Courses (11 Credits):

A set of 3 (three) required Trimester Courses and in-person courses

- Ubiquity Chartres Academy, meeting annually in Chartres, France (4 credits in-person)
- The Creative Journey to Dissertation: Finding your Voice, Making your Mark (Gyorgyi Szabo, PhD) (4 credits online)
- Great Books (3 credits online)

Elective Courses (13 Credits):

An additional selection of Trimester Courses, (or equivalent micro-, nano-, or in-person courses), you take based on your interests.

You can choose your remaining courses from the selection of online trimester, micro and nano courses, and in-person learning journeys or additional coursework from another source approved by the Dean of Graduate Studies.

Dissertation (36 credits):

Complete your academic dissertation.

Candidate Review

Once a student has completed all required courses and has decided on an area of study and a focus of inquiry, and has completed an Advising Agreement with a Major Advisor, the Dean of Graduate Studies will convene a Candidate Review. This meeting will be conducted on Zoom between the student, the Major Advisor and the Dean of Graduate Studies.

The purpose of the Candidate Review is for the faculty and the student to assess the student's readiness to embark on a research study. In addition, questions from the student and the Advisor will be addressed. The student should demonstrate a basic understanding of the research process and be able to identify the major authors that will provide the foundation of the literature review. If a student needs additional advice or support in preparation for the Candidate Review, he/she should contact the Dean of Graduate Studies.

PhD Dissertation

There are five principal criteria for successful PhD dissertations:

1. Each dissertation must demonstrate knowledge of the field in question and be an original contribution to that field. The dissertation must show both a comprehensive knowledge of the philosophy and history of the domain being considered, and demonstrate that the student has added something original to that field. Original contributions can cover a wide range of topics and media.
2. The inquiry, whether in the form of a more traditional qualitative study or a creative project, must utilize a specific research methodology, or a combination of methodologies. The student should be quite familiar with the methodology used and be able to defend the choice as appropriate for the inquiry.
3. All dissertations, without exception, must follow the American Psychological Association (APA) style of writing. This format allows for uniformity in University dissertations and provides a threshold criterion to which all students must adhere in preparing their dissertations. The APA style must be followed in order for the dissertation to be submitted.
4. Dissertations must demonstrate subject/object synthesis. At the Wisdom School we require both a rigorous demonstration of objective knowledge of the field and an equally rigorous insight into one's interior journey. In our view, it is the capacity to combine an objective grasp of the material under consideration, and also engage in the introspective work of discerning how the material is actually affecting one's inner life and soul growth, that is a mark of wisdom.
5. Our vision is to bridge the gap between inner and outer sciences. This is an important criterion for research questions that can be accepted by this PhD Program.

Dissertation Preparation

The intensive course, "The Creative Journey to Dissertation: Finding your Voice, Making your Mark" is particularly important as it relates to writing the dissertation. During this Intensive, students will familiarize themselves with the writing and research methods specific to a wisdom school—which combines objective analysis of data with subjective response—as students grapple with the material they are studying. We are interested in the student's interior journey, as well as objective comprehension of the materials being studied. Also, during this Intensive, students will familiarize themselves with the APA style of writing, the format that Ubiquity University requires for its dissertations. Students are also encouraged to use the APA style for all their pre- and post-papers.

During the class, students will have ample opportunity to discuss and share their ideas and plans for their dissertations, as well as generate ideas for research and study, both with the professor and with their student peers. Students are encouraged to attend this Intensive early on in their doctoral studies, and then repeat it as many times as they feel the need in order to discuss their progress with faculty and peers in a group setting. Full tuition payment is required the first time the class is taken. Thereafter, PhD students pay \$300 and MA students pay \$200 if they need to repeat the course.

Dissertation Defense

Once the dissertation has been approved by the Major Advisor, Chief Academic Officer of Ubiquity University, External Examiner and the Dean of Graduate Studies, a Dissertation Defense will be scheduled. The student must defend his or her dissertation before a committee of examiners, including the Dean of Graduate Studies, the Major Advisor, Chief Academic Officer or the President of Ubiquity University and an External Examiner who is a specialist in the field in which the dissertation has been written.

The Dissertation Defense can lead to approval or a recommendation to the student that further work is needed. Once any necessary revisions are completed and the Dissertation Defense Committee has given approval, the Dean of Graduate Studies notifies the student the PhD degree is awarded.

Graduation

The following requirements must be met prior to graduation:

- Students must have their Dissertation approved by their Major Advisor and submitted to the Dean of Graduate Studies. The submission should include a cover page with the Major Advisor's signature.
- Students' fees and all financial obligations to Ubiquity University must be fully paid, and all requirements for the degree must be met, before a student can graduate.
- A completed dissertation, required for the Ubiquity University library, must be submitted electronically to Ubiquity University in PDF format within one month after graduating.

Please note students can submit their dissertation at any time of year, but be aware that there may be a delay in response over spring and winter holidays such as Easter and Christmas, and in mid-July.

Doctor of Ministry (DMin) in Engaged Wisdom

The DMin degree is one of the professional doctorates. A DMin is specific to the pastoral and therapeutic communities. It arose originally for ministers in search of a doctoral degree. These ministers were less interested in the pure research required for a PhD than in a focus on developing skills in application-oriented research in specific areas, among them healing, therapy, spiritual direction and counseling. Their dissertation subject matter focused on areas more connected to their professional work. Upon completion of Ubiquity's Doctor of Ministry program, you are awarded the title "Doctor of Ministry."

All the requirements are the same as for the Ubiquity PhD programs above, except that 36 credits must be completed from courses plus 24 credits for the doctoral dissertation, totaling 60 credits.

Combined MA/PhD in Wisdom Studies, MA/DMin in Engaged Wisdom

Given the requirement to have a Master's degree before pursuing a PhD degree, we also have a combined MA/PhD in Wisdom Studies enabling you to get your MA qualification first and then continue studies toward your DMin. This program is composed of 80 credits consisting of 44 credits online or in-person (20 credits at the MA level and 24 credits at the PhD level) plus 36 credits allocated to a doctoral dissertation. If you're interested in this option, please discuss it with Dr. Gyorgyi Szabo, Dean of Graduate Studies.

Graduate Degrees with Partner Institutions

In addition to Ubiquity's self-administered degree programs, we also partner with other education service providers to give their students an opportunity to up-level their certifications to graduate degrees. What this means is that students enrolling in a partner program, or those who have completed that certification, can earn a graduate degree by completing their Master's thesis or Doctoral Dissertation with Ubiquity.

Students have the option of choosing to pursue a Masters, PhD, DMin or MA/PhD or DMin degree.



The Pathway from Certification to Degree

Students interested in any of the Partner Programs above follow these steps on their pathway to a graduate degree.



Prerequisites for Enrollment

Students are required to have achieved a prior level of education or work/life experience to qualify for these programs.

- Master's applicants must have a Bachelor's Degree (or equivalent work/life experience in that field)
- PhD applicants must have a Master's Degree (or equivalent work/life experience in that field)

As a holistic University, Ubiquity recognizes that the majority of human learning takes place outside of formal education and is committed to working with you to determine if past professional and life experience can **apply toward your academic requirements**. Program Requirements

All graduate students entering Ubiquity (MA, PhD, DMin or MA/PhD candidates) are required to complete [the Creative Journey to Dissertation course](#). This 5-day, online intensive is designed to prepare you for the challenges and rigours of writing a graduate thesis/dissertation. Students entering from partner programs are required to complete this course before finalising a topic for their thesis/dissertation and before choosing their Major Advisor.

Students will select a Master's or PhD advisor at the start of the dissertation/thesis writing process. They may select an advisor of their choice or they may choose from Ubiquity's pool of advisors as well (see the link below).

An MA thesis should be between 50–80 pages in length.

A PhD dissertation or MA/PhD dissertation should be around 200–250 pages in length.

Curricular Requirements

- For MA students, the Creative Journey to Dissertation course is the only course requirement.
- PhD and DMin students are required, in addition to the Creative Journey to Dissertation, to take:
 1. The Chartres Academy (online or virtual)
 2. The Great Books
- Combined MA/PhD or DMin candidates will need to complete all of the PhD requirements listed above in addition to elective courses adding up to 8 Masters Credits.

How long will it take to complete my program?

The time it takes to complete an MA thesis or a Ph.D. dissertation largely depends on the amount of time that is available to you and your schedule, and so can vary greatly.

On average, including time spent with the partner, an MA partner program takes 2-3 years to complete. A PhD or DMin dissertation takes 3–5 years to complete. And a combined MA/PhD or DMin takes up to 6 years to complete. If the partner curriculum has already been completed, an MA can be completed in 6–12 months; PhD in one-two years; and MA/PhD in three years.

If you need longer than the suggested timeframe to complete your degree requirements then we invite you to communicate with your advisor and the Registrar's Office directly. Ubiquity is committed to supporting individual students and their particular circumstances. However, there is a strict time frame imposed on taking core and elective courses with a view to provide structure, motivation, and the knowledge-base needed to write an effective thesis or dissertation.

Additional Payment Information

All students have a choice of paying their whole degree tuition upfront for which they will receive a discount, or paying overtime in three (3) installments. Should you choose to pay in installments, the following conditions apply:

- All students pay the first installment of their graduate fees upon admittance to Ubiquity. These fees are \$2,000 for the MA and \$5,000 for the PhD, DMin, and combined programs.
- All students pay the second installment no later than six (6) months after enrollment. For MA students this amount is \$1500. For PhD, DMin and MA/PhD students, the sum of \$5000 is paid before enrolling in core courses and electives (Chartres Academy, Great Books, Electives) and no later than 6 months after enrollment.
- MA students need to pay their third and final installment when they submit their thesis or no later than 18 months after enrolment. PhD and DMin students (\$5000) and MA/PhD students (\$6,600) need to make their final installment payment prior to officially selecting their Major Advisor or no later than 18 months after enrolment.

Final Creative Assignment

This final Creative Assignment requires both an intellectual written component showing mastery of the content of the instructional material and an artistic expressive component through any media of the student's choosing.

We use [APA guidelines](#).

Intellectual Written Component:

- BA or Certificate Level – Six (6) to Nine (9) Pages
- MA Level – Twelve (12) to Fifteen (15) Pages
- PhD Level – Twenty (20) to Twenty-Five (25) Pages

Your paper should address the following three aspects of your learning experience:

1. **Demonstrate knowledge:** Address at least three of the main points raised by each course from the intellectual perspective. What did you learn about the topics that were presented?
2. **Demonstrate self-mastery:** Address how you personally feel about the points raised. Did you have any personal revelations? Did you learn something that changes your perspective either internally about yourself, or externally about the world?
3. **Demonstrate impact:** What will you do to apply your new knowledge and perspective in your daily life. Please give examples of how it may change how you interact with your peers, workplace or our global society at large.

Artistic Expressive Component:

Please post an image of, or a link to, your artistic project at the end of your written paper with a 250–300 word explanation as to what you were wishing to express with it. Your artistic expressive component may be done through any media of your choosing. This could include such items as:

1. An audio/visual presentation (2–3 minute video)
2. Poetry, or other forms of written or spoken word
3. Musical composition
4. Filmed choreography
5. Photographic evidence of a work of art you have created
6. Other project of your choosing

Artificial Intelligence (AI)

Guidelines and Policy for Research, Post-Paper and Dissertation/Thesis Writing

We live in an Artificial Intelligence infused world where the rapid spread of the use of this technology call for policy and institutional guidelines for following a graduate path. At Ubiquity university, we believe that our students should be informed about the conscientious use of AI to become responsible researchers, writers and critical thinkers. At Ubiquity, we support the use of AI tools in research and writing a post paper, dissertation/thesis within clear guidelines.

AI is transforming research, making scientific and philosophical works more efficient and accelerating discovery. While generative AI tools offer speed and convenience in producing text, images and code, researchers must also be mindful of the technology's limitations, including plagiarism, revealing sensitive information, or inherent biases in the models.

Research is one of the sectors that could be most significantly disrupted by generative AI. AI has great potential for accelerating discovery, leading to new research breakthroughs and significant productivity gains, and improving the effectiveness and pace of research and verification processes. However, the technology also entails the risk of abuse. Some risks are due to the tool's technical limitations, and others have to do with the (intentional or unintentional) use of the tool in ways that erode sound research practices.

The impact of generative AI on research and various aspects of the scientific process calls for reflection, for example, when working with text (summarizing papers, brainstorming or exploring ideas, drafting or translating). In many respects, these tools could harm research integrity and raise questions about the ability of current models to combat deceptive scientific practices and misinformation.

AI and Privacy

The improvement of AI technologies presents not only increased efficiencies and deficiencies, it also impacts on data privacy. AI systems often rely on vast amounts of data, including personal and sensitive information, to function effectively. This data-driven approach allows for potential risks for unauthorized access, data breaches, and misuse of personal information. The privacy concerns of transparency, accountability, and data subjects' rights need to be considered when using any AI system.

Key principles for the responsible use of generative AI in research are:

- Reliability in ensuring the quality of research, reflected in the design, methodology, analysis and use of resources. This includes aspects related to verifying and reproducing the information produced by the AI for research. It also involves being aware of possible equality and non-discrimination issues in relation to bias and inaccuracies.
- Honesty in developing, carrying out, reviewing, reporting and communicating on research transparently, fairly, thoroughly and impartially. This principle includes disclosing that generative AI has been used.
- Respect for colleagues, research participants, research subjects, society, ecosystems, cultural heritage and the environment. Responsible use of generative AI should consider the limitations of the technology, its environmental impact and its societal effects (bias, diversity, non-discrimination, fairness and prevention of harm). This includes the proper management of information, respect for privacy, confidentiality and intellectual property rights, and proper citation.
- Accountability for the research from idea to publication, for its management and organization, for training, supervision and mentoring, and for its wider societal impacts. This includes responsibility for all output a researcher produces, underpinned by the notion of human agency and oversight.

The key principles of using AI in writing a post paper, dissertation/thesis:

One distinguishing characteristic of a Ubiquity University post paper, dissertation/thesis is the expectation of a synthesis of the objective with the subjective. Just as the pedagogy of Ubiquity University honors both intellectual and creative/artistic learning, the successful essay, thesis/dissertation demonstrates rigorous critical thinking along with insights regarding the interior journey. The capacity to combine an objective grasp of the material under consideration with the introspective work of discerning how the material actually affects one's inner life and soul-growth: that, in our view, is the mark of wisdom.

To use C.G.Jung's words, "It doesn't matter what you say, but what it says in you. To it you must address your answers. God is straightway with you and is the voice within you. You have to have it out with that voice."

Ubiquity university requires students to do their own writing and not using AI in a primary capacity to structure, draft and complete a post paper, dissertation/thesis. Our School values and academically awards original ideas, creativity and the depiction of inner growth process expressed in a post paper, thesis or dissertation. We trust that our students are not seeking any technology to write and to receive a diploma for a work that is not predominantly created by the student him/herself.

In summary

Generative AI may create possibilities and risks that can be hardly anticipated and fully comprehended today. These guidelines are based on the current state of the technology and the surrounding policy landscape. Given the dynamic nature of both, these guidelines will have to adapt and evolve consciously as AI capacities evolve.
